#### Introduction

Nova Southeastern University College of Pharmacy's ShadowRx program is a formalized shadowing opportunity for our first year (P1) through third year (P3) students. This program will provide a chance for our students to get a glimpse into different practice areas and specialties before they rank and begin their Advanced Pharmacy Practice Experience (APPE) rotations. Shadows give a student an opportunity to network with top professionals in pharmacy and build new relationships. This experience and exposure into the profession helps tailor the direction a student may go in his or her careers.

Shadows are mainly described as a 2-4 hour in person experience into the profession at a specific site of interest. Shadows may also be reduced to a 1/2hr to 1 hr time block via in person (meeting such as lunch or coffee) or by phone/video conference. Some specialty sites may have policies and/or barriers to entry into that specific site, but meeting with professionals that work and lead within those areas helps to fortify the "big picture" approach.

**Table1**. Each year (P1-P3) students will be required to shadow a pharmacist or related professional approved through the NSU College of Pharmacy Career Development Center (CAREERx Space). This requirement is held through our leadership course.

# Responsibilities of the Shadow<sub>Rx</sub> Mentor

Shadow Mentors are a vital piece to the development stages, both personally and professionally. Shadow Mentors play a major role in helping students gain knowledge about the profession, and in most cases a hands on experience within a specific site of interest. Shadow mentors will help to shape the careers of NSU College of Pharmacy's students.

#### Mentors should ensure the following:

- o Communication is made within a week of request from a student.
- Any form of communication should be saved to ensure accountability for the students and any concerns made.
- Shadow mentors should expect to spend up to 4 hours observing a "day in the life of" a pharmacist in your chosen practice area. You may spend longer than 4 hours as long as you and your mentee are available. Shadows are mainly described as a 2-4 hour in person experience into the profession at a specific site of interest. Shadows may also be reduced to a 1/2hr to 1 hour time block via in person (meeting such as lunch or coffee) or by phone/video conference. Some specialty sites may have policies and/or barriers to entry into that specific site, but meeting with professionals that work and lead within those areas helps to fortify the "big picture" approach.
- Each Shadow experience should be documented through our post-experience follow-up survey.
- o For phone/video conferencing: (ie. Telephone, Skype, GoToMeeting, etc).
  - o Ensure internet or phone connection is working properly.
  - Make sure your atmosphere is quiet, provides enough lighting for a face-to-face conversation, and has minimal to no distractions (if video option is utilized)
  - Be sure to connect at least 2 minutes prior to the meeting start, to ensure all programs are functioning and be prepared to contact the necessary point person in case there are any issues.

# Responsibilities of the Shadow<sub>Rx</sub> Mentees

Nova Southeastern University College of Pharmacy's ShadowRx program is an important approach to development and growth. The program offers a great experience and exposure into the profession. Students will need to hold themselves to the highest account and should strive to build long-term connections and professional relationships while on their shadow experience.

- Dress professionally
- Maintain professionalism between you and your mentor
- o Clearly state your goals and intentions so your mentor can better assist you.
- Keep your professional profile up to date and ensure you're meeting all required tasks in the agreed manner
- o Be honest
- Listen to different perspectives
- o Complete pre- and post-surveys regarding your expectations and experience at your site
- Expect to spend up to 4 hours showing/describing what a "day in the life of" a pharmacist in your chosen practice area. You may spend longer than 4 hours as long as you and your mentor are available.

#### o For video conferencing:

- o Ensure internet connection is working properly.
- Make sure your atmosphere is quiet, provides enough lighting for a face-to-face conversation, and has minimal to no distractions
- Be sure to connect at least 2 minutes prior to the meeting start, to ensure all programs are functioning and be prepared to contact the necessary point person in case there are any issues.
